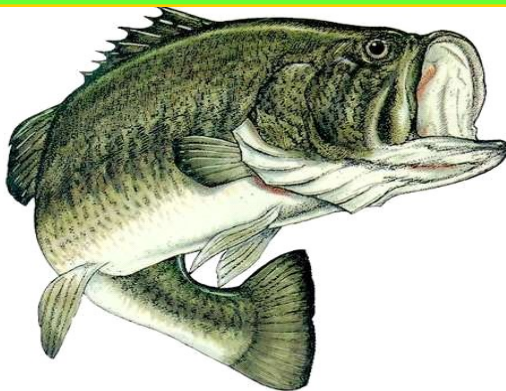
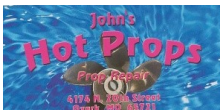

Tournament Rules

1. **RULES:** The following rules for the tournament will be used. These rules will be interpreted solely by the tournament committee and all decisions are final.
2. **TOURNAMENT COMMITTEE:** The tournament committee shall be appointment by Lost Creek Bass Club.
3. **ELIGIBILITY:** Each boat must have a school age student (K-12) and one person over age 18.
4. **ENTRY FEE:** \$65.00 per boat. Late entries will be accepted at the launch ramp. No mail entries will be accepted after May 4, 2015. We reserve the right to assign flights and hours if necessary.
5. **HEADQUARTERS, TIME AND DATE:** What's Up Dock, Port of Kimberling, Saturday, May 9, 2015. The first flight time is 8 a.m. to 3p.m.
6. **DEPARTURE:** Will be in sequence in which entry fees are received.
7. **TACKLE AND EQUIPMENT:** Only artificial bait or lures may be used for catching bass. Pork-style baits are allowed. All fish must be caught on rod and reel.
8. **BOATS AND MOTORS:** Boats may not be trailered during the tournament except for an emergency (example severe weather) without approval from tournament committee. All Missouri Water Patrol Laws and regulations shall apply.
9. **SAFETY AND SPORTSMANSHIP:** Safe boating and fishing practices must be observed. Life jackets must be worn at all times the gas motor is running. Kill switches are highly recommended. All Missouri Department of Conservation laws and regulations shall apply.
10. **PERMITTED FISHING LOCATIONS:** Anywhere on the tournament lake, except within 50 yards of (A) gas dock (B) another contestant's boat at anchor or any location where deemed off limits tournament committee, by Federal or State law.
11. **BOAT IDENTIFICATION:** By contestant number.
12. **SCORING:** Only largemouth bass, spotted bass and smallmouth bass will be counted. Total team weight will determine place; only bass 15 inches or longer will be counted. Any bass that does not meet minimum length will cause a 1 lb. To be deducted from the team weight. The Golden Rule will be the official board of the tournament. Five bass per team limit. One (1) pound will be deducted for each dead fish weighed in. No iced or frozen fish will be weighed. This will result in automatic disqualification. All fish alive will be returned to the lake. There will be a trophy for a non-bass species for kids only.
13. **PROTESTS:** Protests must be filed in writing with the tournament Committee within 15 minutes of the conclusion of the weigh-in.
14. **TIES:** In case of a tie, the winner will be the team with the most fish. If a tie still exists, the winner will be determined by the earliest entry.
15. **CHECK-IN LATE PENALTY:** If you are late you are disqualified. **NO EXCUSES.** All participants must check-in at the appointed area at the weigh-in sight.
16. **LIABILITIES:** By his or her signature the adult and parents of the child releases the Fish Tales and all other contestants, sponsors, host club, and tournament officials.
17. A polygraph may be given to Adults at the decision of the tournament committee.
18. All boaters are required to have boater's liability insurance, minimum of \$100,000.
19. All fish must be brought to the weigh-in in the issued tournament weigh-in bags. Fish not brought in the issued weigh-in bags will not be weighed.
20. **NO REFUNDS.**
